**Subject: November 11, 2010 NYWYSA Nominating Committee Report**

Two (2) positions on the NYWYSA Board of Directors (BOD), 1<sup>st</sup> Vice President and Treasurer, are open for election at the November 13, 2010 NYWYSA Annual General Meeting (AGM) to be held at 4:15 P.M. at the Rochester Marriott Airport Hotel in Rochester, NY.

An announcement that these positions were open for election was posted on the NYWYSA Website ([www.nyswysa.org](http://www.nyswysa.org)). Nominations of persons interested in serving the membership of the NYWYSA in these capacities were to be sent to the Rochester District Commissioner/NYSWYSA Nominating Committee Chairman Roger J. Best. The nomination was to include a resume providing the candidate's qualifications and cover letter stating the reasons for interest in the position. As of this date, no nominations for either of the positions have been received.

Incumbent NYWYSA 1<sup>st</sup> Vice President Curt Regruit has announced his candidacy for reelection to the position of 1<sup>st</sup> Vice President. Curt was elected to the position of NYWYSA Secretary at the November 13, 2005 NYWYSA AGM and reelected to that position at the November 17, 2007 and November 14, 2009 AGM's. Upon the recommendation of the NYWYSA President Rich Wagner, he was appointed to his current position with the unanimous approval of the NYWYSA BOD at the August 8, 2010 NYWYSA BOD Meeting.

Incumbent NYWYSA Treasurer Matthew (Matt) Quinlan has announced his candidacy for reelection to the position of Treasurer. Matt was appointed NYWYSA Treasurer upon the recommendation of then NYWYSA President Michael Radecke with the unanimous approval of the NYWYSA BOD at the October 14, 2009 NYWYSA BOD Meeting. Prior this appointment, he served as the Treasurer of the Irondequoit Soccer Club for six (6) years.

Although the incumbents are the only candidates for each of the positions open for election on the NYWYSA BOD, the NYWYSA Nominating Committee considers both candidates to be very well suited and highly qualified. This has been clearly demonstrated by both of them during the time that they have held their respective positions. They have performed the various functions and responsibilities of their positions with integrity and in a timely and professional manner. Therefore, the NYWYSA Nominating Committee highly recommends Curt Regruit for the position of NYWYSA 1<sup>st</sup> Vice President and Matthew Quinlan for the position of NYWYSA Treasurer.
